### LOAD IN/LOAD OUT PROCEDURES

1. Early Load in / setup will be available on Friday April 25th, between 9:00 am-3:00 pm. If you opt out of early Friday set up, general set up is **Saturday beginning at 7:00 am. You must be completely set up no later than 8:30 am. (Late setups or early breakdowns will not allow for you to participate in future events.)** A staff host will be available to answer questions during your setup.
2. Please work with our staff host to arrange for your vehicle to enter the venue for load out. Failure to respect loading procedures will not allow you to participate in future events. **As a vendor, you agree to remain open until the end of the event.**
3. Do not block traffic during your load out. Your patience during the load-out process is appreciated.
4. You will be responsible to bring your own help, rolling carts, hand trucks to load into your vendor space. Staff and volunteers are not responsible for loading in, setting up or loading out vendor items.
